Towers, Ahmedabad, Gujarat by Wheat Products Promotion Society (WPPS), Roller Flour Millers' Federation of India (RFMFI), Gujarat Roller Flour Millers' Association (GRFMA), Society, Society of Indian Bakers (SIB) and All India Bread Manufacturers' Association (AIBMA). The International Seminar, fifth in the series, was co-



sponsored by a total of 18 organisations including Public and Private Sector organisation, Machinery Manufacturers, Traders, Associations, International NGO's working in the nutrition sector both from India and abroad. More than 250 delegates and invitees attended the Seminar. The Seminar was inaugurated by Dr. S. K. Nanda, IAS, Principal Secretary, Forest & Environment Department, Government of Gujarat.

WPPS honored and felicitated Dr. S. K. Nanda and Dr. Saraswati Bulusu for their contribution towards Wheat Flour Fortification program. Special mementoes and flowers were presented on behalf of Wheat Products Promotion Society.

Proceedings of the seminar in printable and CD format including all presentations and seminar photographs, was finalised for release on April 16, 2010. Mr. Siraj Hussain, Chairman and Managing Director consented to release the same.

WPPS - IFFN collaborative programs

India Flour Fortification Network (IFFN) in association with Wheat Products Promotion Society, A2Z USAID, Flour Fortification Initiative (FFI), Global Alliance for Improved Nutrition (GAIN), Micronutrient Initiative (MI), UNICEF, World Food Program (WFP), World Health Organisation (WHO) and Roller Flour Millers' Federation of India (RFMFI) organised two programs on December 4, 2009 and March 22-24, 2010.

National Consultation on Wheat Flour Fortification was organised on December 4, 2009 at India Islamic Cultural Centre, New Delhi. A total of 77 people from Wheat & Wheat based industries including NGOs participated in the program. The program was result into the following recommendations:

1. Building a consensus on the fortificants to be added, the compound of micronutrients to be used for fortification.
2. Sensitize the policy makers and political leaders about the prevalence of micronutrient malnutrition in India so that suitable environment for fortification of multiple food commodities can be created to address micronutrient deficiencies.
3. Need to develop National Guidelines on Wheat Flour Fortification based on the WHO Guidelines, which would help and guide the states to develop state-specific action plans for wheat flour fortification.
4. Essential to come forward with promotional campaigns to make the communities aware of



the magnitude of micronutrient malnutrition and creation demand for fortified wheat flour in general.

5. Development of a system of quality assurance to safe gaurd the health of the consumer.

Master Training of Trainers Program on Wheat Flour Fortification program was organised on March 22-24, 2010 in New Delhi to train people in Flour Fortification industry. A group of 35 including speakers participated in three-day program from



different states of India.

Mr. Quentin Johnson, Co-ordinator, Training and Technical Support Group of Flour Fortification Initiative (FFI) was key trainer. Other speakers who presented their views and experiences in the field of Fortification on Inaugural day were Dr. Anand Laxman, Coordinator, Planning and Knowledge Management, Micronutrient Initiative - Asia, he presented the overview of global and national malnutrition status in his presentation on Nutrition, Health and Role of Micronutrients; Ms. Deepti Gulati, Senior Associate, GAIN-Asia discussed on Combating Micronutrient Malnutrition: Approaches and Strategies; Dr. Madhavan Nair, Senior Scientist, National Institute of Nutrition, Gol; Mr. Bhaskar Pandya, Regional Director, PSI; Mr. S. C. Kathuria, Deputy Additional Director General (PFA) of Food Safety and Standards Authority of India and Dr. Nidhi Chaudhary, National Program Officer, WHO took active participation in the deliberations in three-day training program.

Mr. Vinod Kapoor, Consultant, Micronutrient Initiative performed a key role in this three-day training program and presented papers on various topics related to Wheat Flour Fortification. A flour mill visit was also arranged at Ganga Roller Flour Mills, New Delhi to gain the practical knowledge on how wheat flour fortification is done.
